- Sportsmen Judges, judge only on the merits of the dogs and considers no other factors.
 - The sportsmen judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsmen exhibitor refuses to compromise the impartiality of a judge.
 - The sportsmen respect the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
 - \bullet Sportsmen welcome, encourage and support newcomers to the sport.
 - Sportsmen will deal fairly with all those who trade with them.
 - Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
